This assessment covers the review of the submission from the operator to satisfy pre-operational measure PO 05 that are required to be completed prior to the start of the well test under condition 2.4.1 of your permit.

Please note that the document that makes up this submission makes reference to the permit EPR/AB3307XD. Following the transfer of the permit, the permit has changed to EPR/GB3609KQ. It is under this permit that the condition is assessed.


PO 05: Vapour Recovery

The document "PO05 Vapour Recovery Plan" Revision 4 was received by email on 21/09/2018. This sets out the plan to install and operate a vapour recovery system at the site for the loading/unloading of crude from the on-site storage tanks to tankers.

The system that is proposed is acceptable and meets the requirements of the pre-operational measure, subject to the following two requirement comments:

- That the design justification to support the statement that any safety venting to prevent over-pressurisation of the system will occur through the on-site storage tank (at 3.3 bar) and that it will not be vented out of the tanker or result in a risk of pressurisation of all other elements of the system.
- That your specialised haulage contractor ensures that they come equipped with a suitable connector to enable their 2" vent line can connect to the 1.5" air line on the tank.

I can confirm that you have met the requirements of this pre-operational measure.
